# 5. 2014-15 Title I School Improvement Initiative 1003(a) Project Application (Lagotic)

School Improvement funds will be used to implement three strategies designed to increase student performance and teacher quality during the 2014-15 school year. The strategies are supplemental and will support implementation of differentiated accountability.

## 6. 2014-15 School Health Plan (Black)

The School Health Plan outlines the provisions and responsibilities of the Department of Health and Alachua County public Schools in providing mandated nursing interventions of the Health Services Program.

# 7. <u>Digital Classroom Plan</u> (Caudle)

As required by state statute, each district shall annually complete a Digital Classroom Plan (DCP) s. 1011.62(12), F.S. Funding has been appropriated to each district to assist with implementation of the DCP. Funding associated with the DCP is subject to the plan's approval by the Department of Education. Each district's plan must be designed to support and implement strategies to improve outcomes related to student performance by integrating technology into classroom teaching and learning. Districts are required to develop a plan with input from stakeholders, including instructional, curriculum and information technology staff. The DCP must be adopted and approved by the School Board and submitted to the Florida Department of Education for final approval. The intent of the DCP is to provide a perspective on what the district considers being vital and critically important in relation to digital learning implementation, the improvement of student performance outcomes, and how this progress will be measured.

## 8. <u>Agreement with the City of Gainesville/Gainesville Police Department (GPD) for the School</u> Resource Officer Program **(Caudle)**

A contract has been prepared for approval by the School Board and by the City of Gainesville, through its Police Department, for the continuation of the School Resource Officer Program. The agreement establishes terms whereby GPD will provide thirteen (13) School Resource Officers and "Officer Friendly" to local schools and centers for the 2014-15 school year. A total of up to \$349,246.80 will be paid by the School Board of Alachua County to GPD for 13 School Resources Officers to provide public safety, prevention and intervention education programs at specified schools.

#### 9. 2014-15 Multi-district Cooperative Agreement for ESE Transition Services (Black)

A Multi-District Cooperative Agreement has been prepared between the School Board of Alachua County, Florida, and Levy County for services for the school year beginning August 18, 2014, to June 30, 2015, for an ESE student residing in Levy County to participate in the District's Transition to L.I.F.E. Program for ESE students ages 18022 who are in need of adult functional skills for employment and independent living.

# 10. <u>Annual Professional Services Ranking for Districtwide Roofing Replacement and Repairs for Project SBAC R1001—Annual Roofing Consultant</u> (Andrew)

Interviews were conducted on September 9, 2014, for the annual districtwide roofing consultant.
