In August, the Board adopted a set of Goals and Outcomes for the plan, including Goal 6-E which states that "The district will increase communication opportunities for stakeholders' engagement on educational issues that have or will have districtwide impact." Understanding the Board's priority for this goal, it has been recommended that a District Advisory Committee (DAC) be implemented for the purpose of improved communication and community engagement. Creation of this committee is consistent with Board Bylaws 0155 for creating committees.

establishment of the District Advisory Committee (DAC), consistent with the recommendations made to the Board in the memo, dated September 13, 2013, concerning this subject. Next steps would include appointment of members to the DAC and development of

bylaws for the committee.
