7. FIRST (For Inspiration and Recognition of Science and Technology) Robotics Program (Roberts)

As we prepare the way for the implementation of a STEAM (Science, Technology, Engineering, Arts, and Mathematics) initiative in Alachua County Public Schools, beginning with the 2015-16 school year, Mr. Jeremy Roberts, computer engineer, will volunteer his time on Thursday, December 4, 2014, to help design for implementation and preparation of our elementary and middle school principals for the launch of the FIRST Robotics Program, which is an international award-winning project-based learning experience. The FIRST Robotics Program will be hands-on and students will design and build robots to perform various tasks and solve a range of challenging problems in a fun and mentally engaging way. Cost to the District will be to reimburse Mr. Roberts for his travel expenses for the day.

8. Financial Management Review (Roberts)

The Florida Association of District School Superintendents (FADSS) will be conducting a Financial Management Review of the Finance Operation during the week of December 8, 2014. The five-member team will evaluate current organizational structure and operations in order to make recommendations regarding staffing and alignment of work responsibilities, as well as recommend operational efficiencies and best practices.

9. <u>Certificate of Final Inspection for Project SBAC T1302</u>—Oak View Middle School Building 7 Technology Upgrades **(Andrew)**

This project has been inspected by the project architect and the Facilities Department staff. It is requested that the School Board authorize final payment to the contractor upon total acceptance of this project. Final contract amount is \$142,480.

10. Second Amendment to Dual Enrollment Agreement with Santa Fe College (Jones)

A Second Amendment to the Dual Enrollment Agreement with Santa Fe College has been prepared for the purpose of enhancing learning opportunities for qualified high school students.

Collegiate High School Program Agreement with Santa Fe College (Jones)

A Collegiate High School Program Agreement has been prepared to provide 11th and 12th grade students opportunities to shorten the time necessary to complete course requirements for a college degree, to broaden the scope of curricular options and to increase the depth of study available.

12. Contract with DES of Florida, LLC (Lyons)

DES of Florida provides a means for non-instructional employees to be subcontracted to the School Board for a period of one (1) year after their DROP period expires. The School Board previously signed an umbrella agreement with DES. It is recommended that the School Board approve the following DES contract with Judith Williams, Interim Assistant Clerical, Westwood Middle School, for the period of: December 1, 2014 – June 15, 2015, and August 15, 2015 – November 30, 2015.
