Referred to an article about the Chicago Board of Education's spending mistakes during the time their enrollment was decreasing.

SUPERINTENDENT SEARCH UPDATE Mrs. Jackie Johnson, Public Information Officer, reviewed the District Advisory Council (DAC) meeting schedule. She reported that Janine Plavic was selected Chair and Scott Costello Vice-Chair of the subcommittee that will meet with finalists to ask them questions submitted by DAC members.

Mrs. Johnson also reported that she advertised the Superintendent's position with the American Association of School Administrator's membership during their National Conference. The deadline for applications is February 28.
