SCHOOL IMPROVEMENT GRANT OPPORTUNITY

Mr. Everett Caudle, Executive Director, Project Development, presented information on a School Improvement Grant opportunity. He reviewed the items the funding would cover, as well as the grant requirements. Mr. Caudle then responded to Board member questions. Dr. McNealy will phone Mr. Caudle with more specific questions.

Mr. Caudle emphasized the short timeline for the scope of work that would be required to complete the application. There was Board consensus to move forward with the Intent to Apply form. Board members will communicate comments to Mr. Lyons this week, so decisions can be made on whether to continue with the grant and, if so, which model will be used, as there must be a decision made on which DOE model to use.

CITIZEN INPUT

A citizen charged discrimination against Jewish students because Open House and FCAT were scheduled during religious holidays. Requested FCAT dates to be rescheduled and more sensitivity shown, as relates to religious practices. Superintendent Karen Clarke will work with the parents on this issue.

APPROVAL OF THE STRATEGIC PLAN GOALS, OUTCOMES, AND ACTION PLANS FOR 2013-2016 In response to a Board initiative, and beginning in February 2012, the process of developing a revised Strategic Plan for Alachua County Public Schools was begun. Over the past two years, the Board has taken public input through a series of workshops and public input sessions. A series of Goals and Outcomes aligned to this input were developed and approved for the SBAC Strategic Plan in August 2013. Subsequently, Action Plans were developed by district staff and by individual Board members aligned to each of the Goals and Outcomes. Through a series of additional workshops in late 2013 and early 2014, the Board refined and finalized all the Goals, Outcomes, and individual Action Plans to be included in the School Board of Alachua County's Strategic Plan, 2013-2016.

Motion by Dr. McNealy Seconded by Mrs. Griffin

<u>Moved the</u> Superintendent's recommendation to approve the Strategic Plan Goals, Outcomes, and Action Plans for 2013-2016, as presented.

Dr. Paulson commented that the Strategic Plan and the District Advisory Council are giving a voice to the community.

Dr. McNealy thanked Dr. Paulson for his perseverance on the Strategic Plan issue. Mr. Caudle expressed appreciation to Mrs. Hollinger, who laid the foundation for the finished product, to be approved tonight.

There was no citizen input.

BOARD MEMBER/ SUPERINTENDENT REQUESTS Mrs. Griffin commented:
