Donna Schroeder, Glen Springs 2014 Teacher of the Year, addressed the Board concerning Early Childhood Education. She emphasized the importance of establishing a strong foundation on which children can build. Ms. Schroeder then conducted a PowerPoint presentation, which included a look at Multiage Classrooms, Differentiated Instruction, Student-Led Learning, and the *Project Friends* program. She stated that if the joy of learning is kept in the classroom, the children will keep learning.
