Chairman Roy pulled for comment Item H.8., Early Intervention Services – Head Start Program; and Item H.12, Design Development/Construction Documents for Project SBAC B1204, Kitchen Air Conditioning at Buchholz, Eastside and Newberry High Schools.

In response to Mrs. Roy's questions about how the 5% Sequestration reduction was achieved, Head Start Director Mrs. Ann Crowell stated that enrollment was reduced from 640 children to 600. In addition, staff will be reduced by 6 people, through attrition. The program has been reduced from 180 days to 175 days.

Dr. McNealy expressed hope that a change might be made before this would go into effect. Dr. Paulson encouraged people to contact their representatives in Congress.

Mr. Keith Birkett, Assistant Superintendent, Planning and Budget, stated that the installation of kitchen air conditioning at BHS, EHS and NHS will take place over the summer.

The school's charter contract (2002-2013) expires on June 30, 2013. The proposed first renewal charter contract sets forth the terms and conditions for operation of the school, and follows the state template. It has a term of five (5) years from July 1, 2013, through June 30, 2018.

She spoke extensively on the plans of the Health Department and UF for a community effort against the problem. Dr. McNealy requested the District's involvement in a grassroots effort and comprehensive plan with other agencies in the community. Chairman Roy concurred.

Mrs. Oyenarte brought up the matter of Board member's attendance at Hawthorne High School graduation. Dr. Paulson stated that he will attend Hawthorne. Dr. McNealy suggested rotation of Board member graduation attendance in the future.

Mrs. Oyenarte requested a review of middle and high school zoning in areas that were affected by elementary rezoning when Meadowbrook Elementary School was opened.

Mrs. Roy requested that all principals make a much stronger push to increase attendance at annual Health Fairs.
