GARDENING EDUCATIONAL TRAINING (G.E.T.) PROJECT

Ms. Kathy Black, Executive Director, Student Services, reported that when the resources of the High School ESE students' *Gardening Educational Training* (G.E.T.) Transition Program did not keep pace with the growth of students, the Patti Shively Foundation made two donations. The first was for \$10,000 during a fundraiser at Cymplify last fall, and another for \$12,000 in July.
