Comments

The Purchasing Department has determined that Guessford Elevator Services is non-responsive based on the below contract provision. Reference Attachment B, page 18, "8. Bidder Qualifications". The IFB states: SBAC has established minimum Bidder qualifications and, at its sole discretion, may request the apparent low Bidder to provide evidence demonstrating that they have the experience and capacity to comply with the provisions of the pending contract. In order to be considered for award, each prospective Bidder shall meet the following criteria:

A. Established Business: Bidder shall be an established firm whose sole or primary business includes the provision of unlimited elevator maintenance and repair services to commercial (business/institutional) accounts as typical in the District. Bidder shall have been continuously engaged in the specified services as the same legal entity within the State of Florida for a minimum of five (05) consecutive years. Demonstration of past successful experience with commercial (business/institutional) accounts within the State of Florida, similar in scope of this contract, shall be required. Project experience shall be verifiable. Negative references, in the opinion of SBAC, may be cause for disqualification of Bidder;

Bid Recommendation

At the next regularly scheduled meeting of the School Board of Alachua County, Florida, the Purchasing Department shall recommend that a annual contract for the provision of elevator modernization services be awarded to **Mowrey Elevator Company of Florida**, the low, responsive and responsible Bidder.
