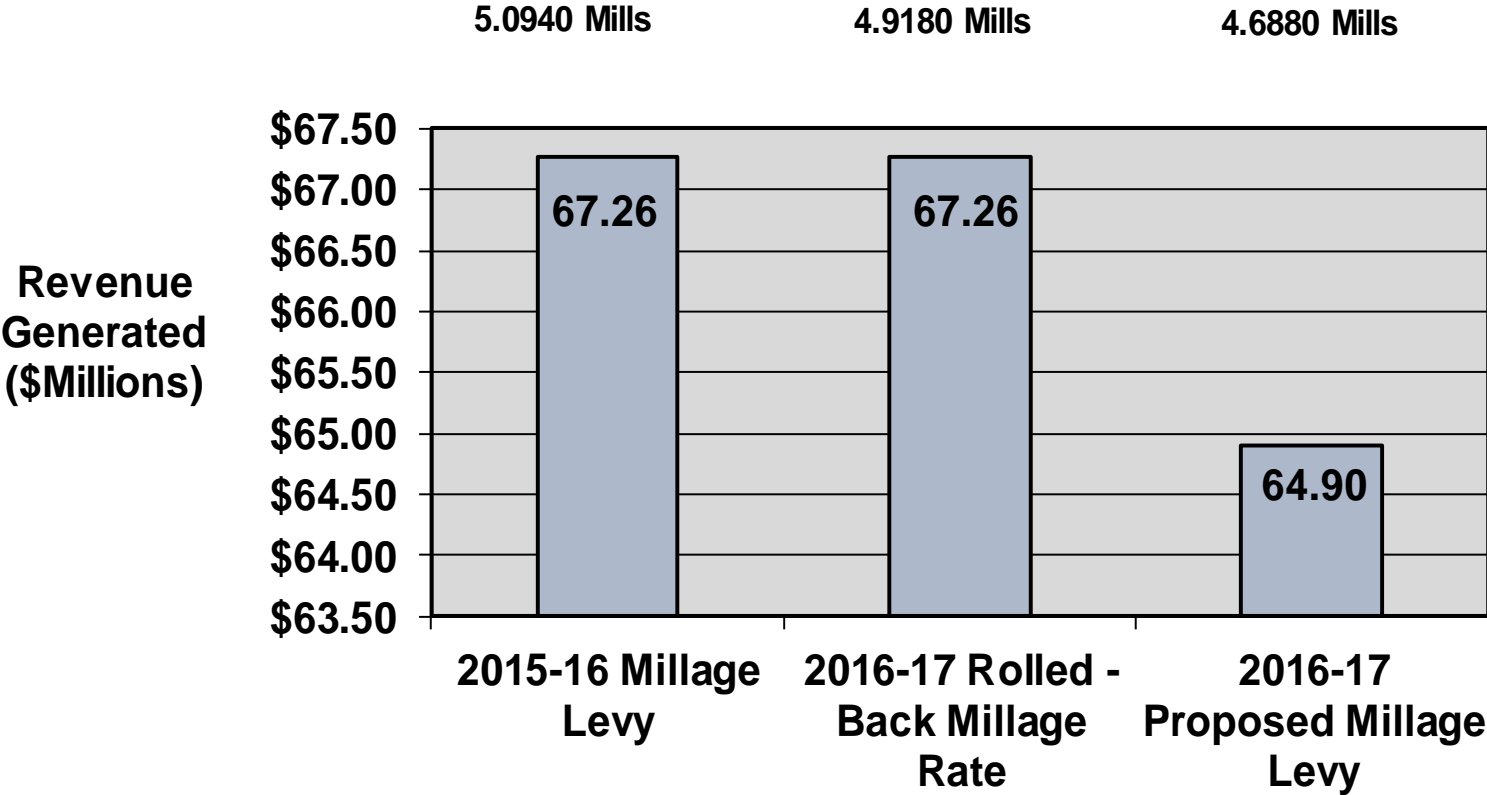

Generates the Same Tax Revenue as the Prior Year.

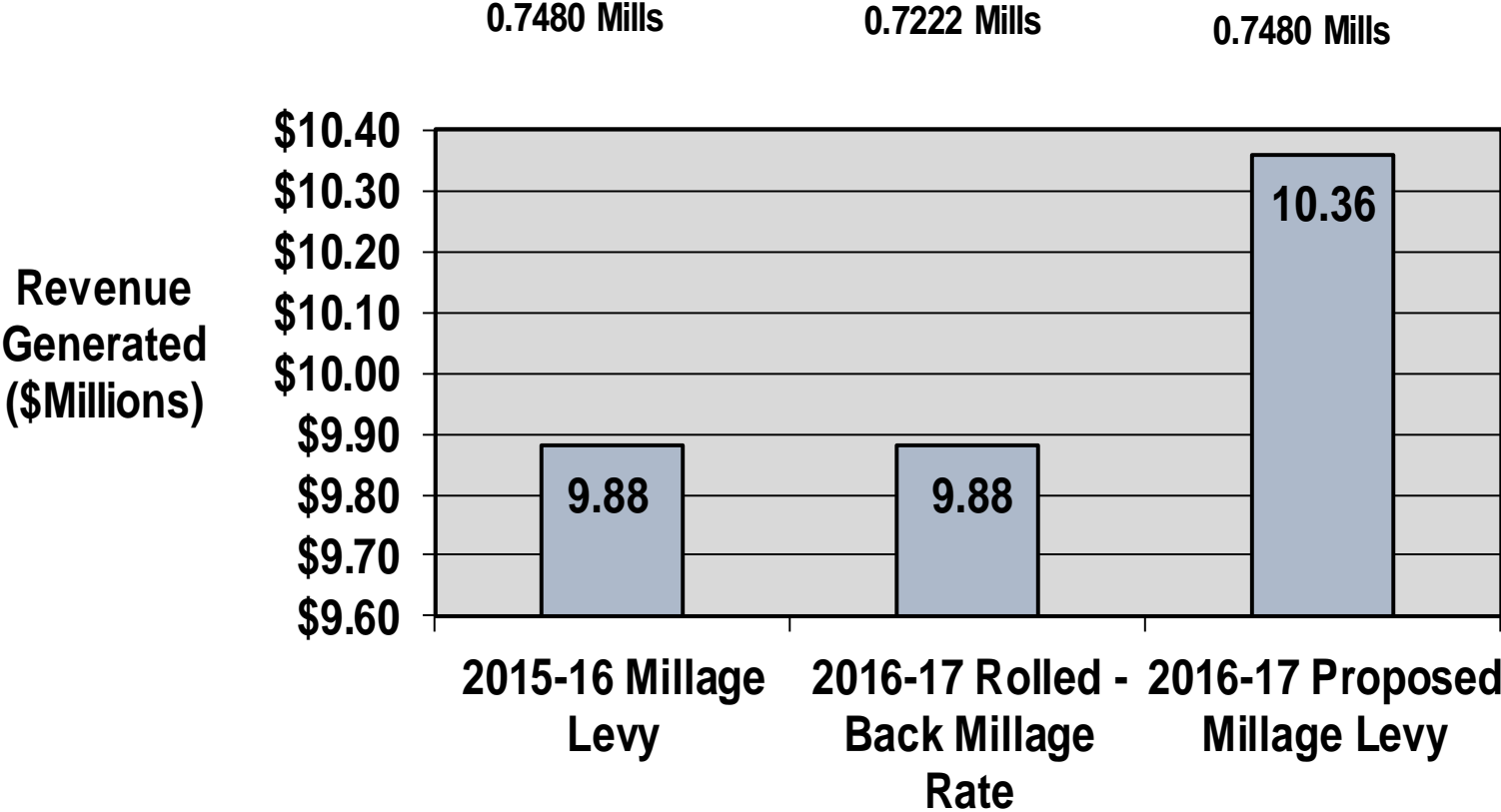

Required Local Effort (RLE)



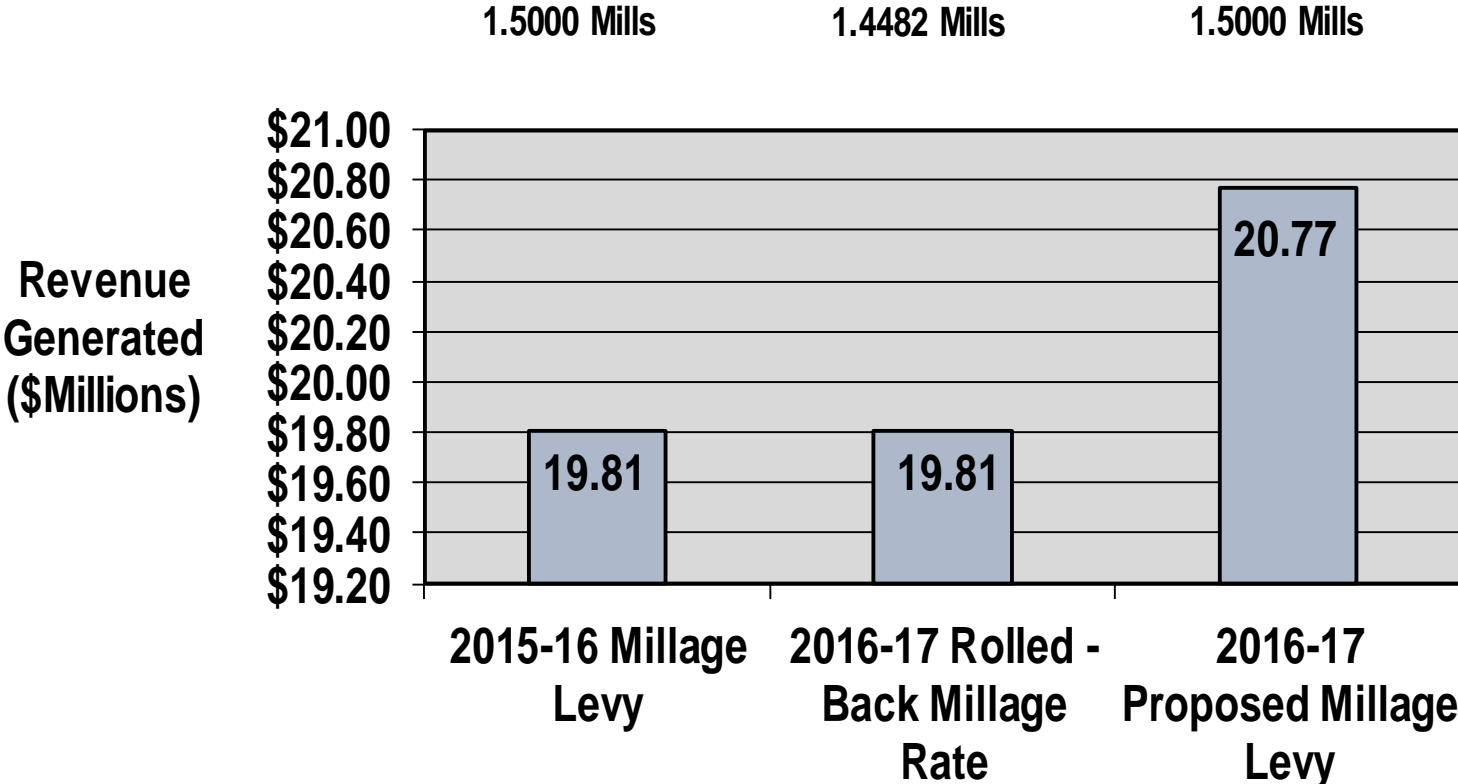

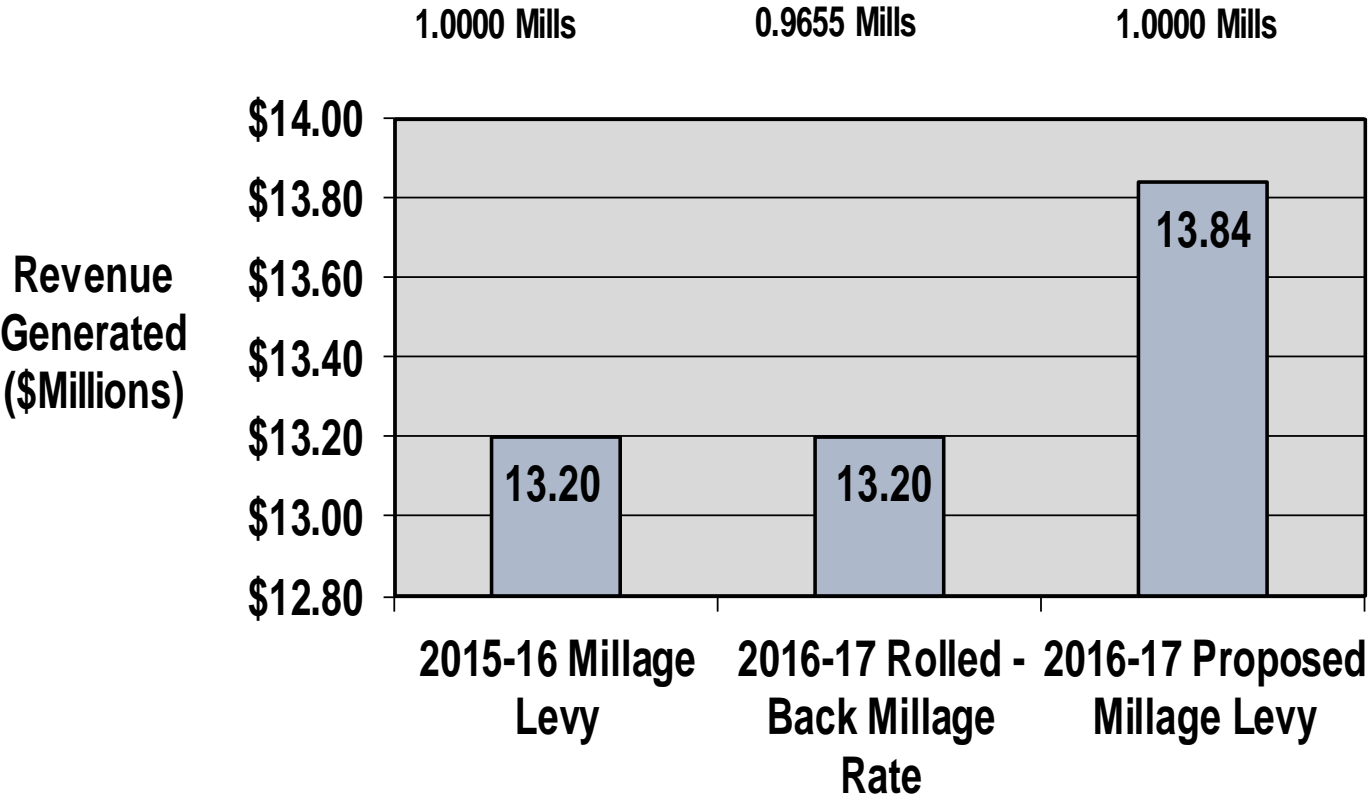

Capital Outlay



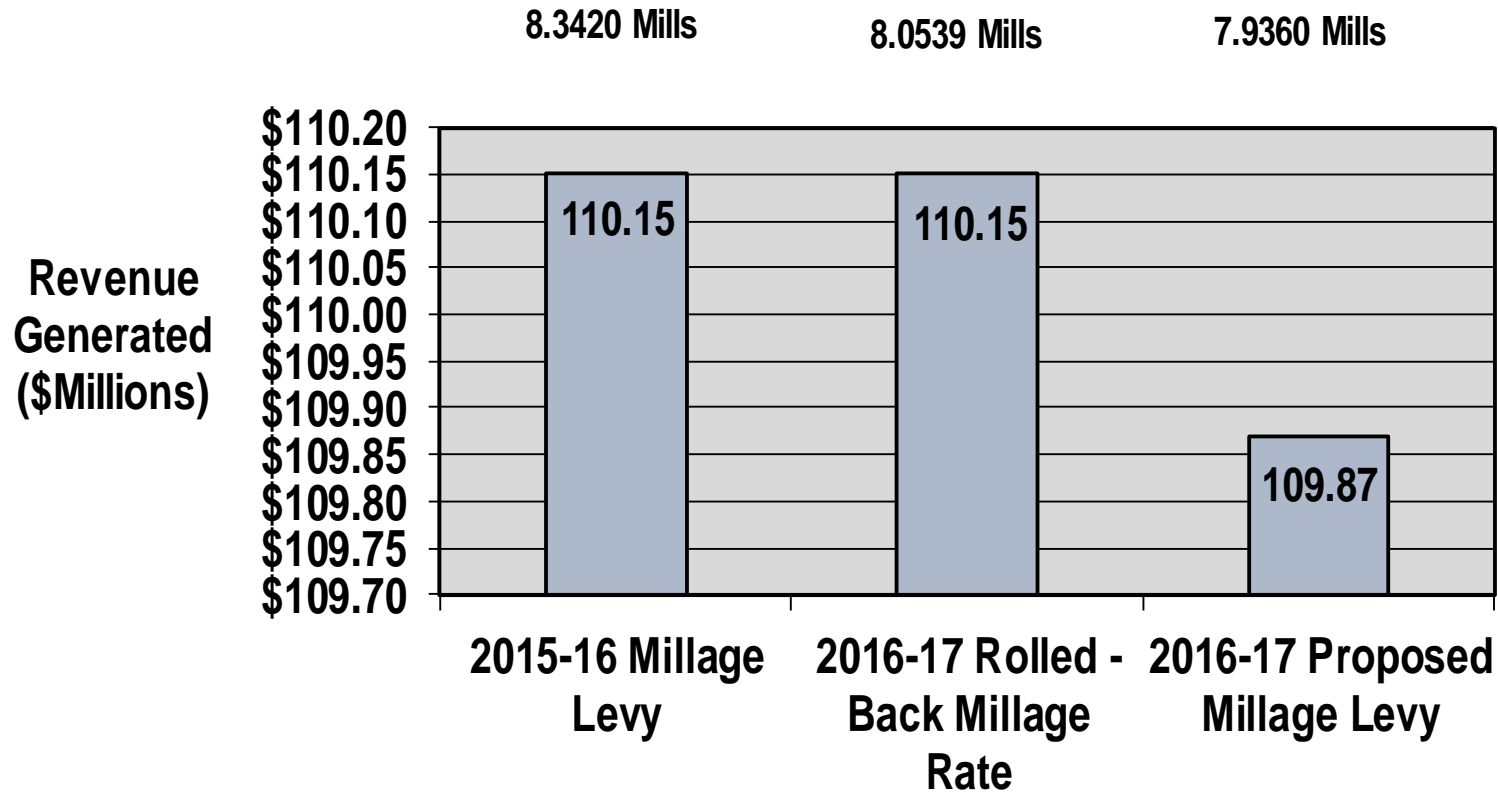

Millage Impact on Taxpayer for Education

Assessment Increases:

If the market value of a home exceeds the assessed value, the assessment will automatically increase by the consumer price index (CPI) or a maximum of 3% per year. For 2016 the CPI is 0.7%. Therefore, the maximum increase in assessment for 2016, assuming no improvements to a home, would be 0.7%.

Millage Impact on Taxpayer for Education (cont)

Assumptions:

- **2016-2017 Assessed Value increased by 0.7%.**
- **House assessed at \$125,875 with a \$25,000 homestead exemption for education with maximum change in Assessed Value.**

WHEREAS, the School Board of Alachua County, Florida, did, pursuant to Chapters 200 and 1011, Florida Statutes, approve tentative millage rates for the fiscal year July 1, 2016 to June 30, 2017; and

WHEREAS, at the public hearing and in full compliance with Chapter 200, Florida Statutes, the School Board of Alachua County adopted the tentative millage rates for fiscal year 2016-2017 in the amounts of:

ADOPTING THE TENTATIVE BUDGET FOR THE FISCAL YEAR 2016-2017**

WHEREAS, the School Board of Alachua County, Florida, did, pursuant to Chapters 200 and 1011, Florida Statutes, approve tentative millage rates and tentative budget for the fiscal year July 1, 2016 to June 30, 2017; and

WHEREAS, the School Board of Alachua County set forth the appropriations and revenue estimate for the budget for fiscal year 2016-2017; and

WHEREAS, at the public hearing and in full compliance with Chapter 200, Florida Statutes, the School Board of Alachua County adopted the tentative millage rates and the budget in the amount of \$347,890,664 for fiscal year 2016-2017.

NOW THEREFORE, BE IT RESOLVED:

That the attached budget of the School Board of Alachua County, including millage rates as set forth therein, is hereby adopted by the School Board of Alachua County as a tentative budget for the categories indicated for the fiscal year July 1, 2016 to June 30, 2017.
