These incidents will be documented as minor offenses.

Some Level II acts may also require schools report to a law enforcement agency, and to the state SESIR reporting system. Incidents documented in the SESIR reporting system will be included on the student's permanent transcripts.

Level I Discipline - A Level I offense is the most serious breach of misconduct; it must be reported immediately to the principal/designee. Such breach of conduct includes, but is not limited to: violence against persons or property and any other act which substantially disrupts the orderly conduct of the school or poses a threat to the safety or security of students, staff and/or community. If you commit a Level I offense, you will be suspended from the regular education program and the principal/designee may recommend alternative placement or expulsion. A Level I act may also require a report to a law enforcement agency, which may result in criminal penalties, as well as documentation in the state SESIR reporting system. Incidents documented in the SESIR reporting system will be included on the student's permanent transcripts.
