


Rolled-Back Millage Rate

Generates the Same Tax Revenue as the Prior Year.


Required Local Effort (RLE)




Discretionary Operating




Capital Outlay

WHEREAS, the School Board of Alachua County, Florida, did, pursuant to Chapters 200 and 1011, Florida Statutes, approve tentative millage rates for the fiscal year July 1, 2014 to June 30, 2015; and

WHEREAS, at the public hearing and in full compliance with Chapter 200, Florida Statutes, the School Board of Alachua County adopted the tentative millage rates for fiscal year 2014-2015 in the amounts of:

Resolution Number 15-02

A RESOLUTION OF THE ALACHUA COUNTY SCHOOL BOARD ADOPTING THE TENTATIVE BUDGET FOR THE FISCAL YEAR 2014-2015

WHEREAS, the School Board of Alachua County, Florida, did, pursuant to Chapters 200 and 1011, Florida Statutes, approve tentative millage rates and tentative budget for the fiscal year July 1, 2014 to June 30, 2015; and

WHEREAS, at the public hearing and in full compliance with Chapter 200, Florida Statutes, the School Board of Alachua County adopted the tentative millage rates and the budget in the amount of \$316,575,864 for fiscal year 2014-2015.
