Knowledge of learning styles and skill in using varied teaching methods to address student learning styles. Skill in oral and written communication with students, parents and others. Ability to plan and implement activities for maximum effectiveness. Ability to assess levels of student achievement effectively, analyze test results and prescribe actions for improvement. Ability to maintain appropriate student supervision so that students have a safe and orderly environment in which to learn. Ability to work effectively with peers, administrators and others.

- *(4) Select, develop, modify and/or adapt materials, technology and resources to support learning objectives and to address students' learning styles and special needs.

- *(5) Create or select goals and objectives for unit and daily plans based on a review of district and state curriculum priorities, student profiles and instructional priorities. *(7) Identify specific intended learning outcomes which are challenging, meaningful and measurable.
- *(6) Apply principles of learning and effective teaching in instructional delivery.
- *(7) Maintain academic focus by using a variety of motivational techniques.
- *(8) Provide quality work for students which is focused on meaningful, relevant and engaging learning experiences.
