- *(1) Administer, as a Third-Party Tester (TPT), the road sign test, the road rules test and the driving skills test.
- *(2) Provide instruction on safe driving in accordance with the prescribed curriculum.
- *(3) Inspect/monitor vehicles to ensure proper operation.

- *(4) Plan, prepare, and conduct a variety of learning activities considering students' learning styles and special needs in order to enhance the application of critical, creative and evaluative thinking capabilities of students.
- *(5) Select, develop, modify and/or adapt materials, technology and resources to support learning objectives and address students' learning styles and special needs.
- *(6) Create or select goals and objectives for unit and daily plans based on a review of district and state curriculum priorities, student profiles and instructional priorities.
- *(7) Identify specific intended learning outcomes which are challenging, meaningful and measurable.
- *(8) Apply principles of learning and effective teaching in instructional delivery.
- *(9) Maintain academic focus by using a variety of motivational techniques.
- *(10) Provide quality work for students which is focused on meaningful, relevant and engaging learning experiences.
- *(11) Sequence content and activities appropriately.
- *(12) Maintain instructional momentum with smooth and efficient transitions from one activity to another.
- *(13) Assist students in assessing, interpreting and evaluating information from multiple sources.
- *(14) Encourage self-assessment by students and assist them in developing plans for improving their performance, as appropriate.
- *(15) Monitor learning activities and provide feedback to students about the appropriateness of responses and quality of work with a focus on improving student performance.
- *(16) Evaluate the effectiveness of instructional units and teaching strategies.
- *(17) Interpret and use data (including but not limited to standardized and other test results) for diagnosis, instructional planning and program evaluation.
- *(18) Develop and use ongoing assessments to monitor student progress to verify that learning is occurring to adjust curriculum and instruction.
- *(19) Administer tests, including standardized tests, in accordance with directions provided, including proctoring and secure handling of materials.
- *(20) Communicate high learning expectations for all students.
- *(21) Foster student responsibility, appropriate social behavior, integrity, appreciation of cultural diversity, and respect for self and others by role modeling and learning activities.
- *(22) Communicate effectively, orally and in writing, with other professionals, students, parents and community.
- *(23) Provide accurate and timely information to parents and students about academic and behavioral performance of students.
- *(24) Write or participate in the formation of student IEP or 504 Plans or any other learning plans based on individual student needs.
- *(25) Establish routines and procedures and encourage students to follow them consistently.
- *(26) Establish and maintain appropriate discipline in the educational setting and effective behavior management techniques.
