Ability to conduct comprehensive psycho-educational evaluations of students. Ability to verbally communicate and consult effectively with parents, school personnel, and the public. Ability to communicate results of evaluation findings in written reports and correspondence to assist students, parents, and school personnel in the resolution of problems in student learning, behavior, and mental health. Ability to interact successfully with parents, school personnel, and administrators. Skills in communicating effectively orally and in writing. Skills and ability to apply and interpret federal, state, and local laws and policies governing the provisions of educational services to students with disabilities. Knowledge of laws and rules relating to education and other services for persons with disabilities. Ability to maintain confidentiality. Knowledge of school curriculum and instructional best practices.
