An individual student report about the performance of the child(ren) on the state assessment will be provided to each parent/guardian, when available, at the end of the year.
- Provide parents/guardians reasonable access to staff. Access to staff will be offered at flexible times throughout the school year such as before and after school, meet the teacher night, open house night, work nights, and by appointments to accommodate the parents/guardians and staff schedules.
- Provide and encourage parents/guardians' opportunities to volunteer and participate in their student's class, and to observe classroom activities any time during the school year by starting the necessary paperwork in the front office.

## Family Pledge: I will

- Make sure homework is completed.
- Participate in decisions related to my child(ren)'s education.
- Promote positive use of my child(ren) extracurricular time.

- Serve, to the extent possible, on school advisory or policy groups.


## Student's Pledge: I will
