Families encouraged to respond to survey

To give school and district leaders the information they need to provide students with a high-quality learning experience, Alachua County Public Schools families are asked to respond to a survey about their child's school.

The deadline to complete the online Insight survey is May 12.

The link to the survey is https://bit.ly/acpsfamilysurvey. It should take about 15 minutes to complete on a cell phone, laptop or other device.

The district is working with a non-profit organization called TNTP to conduct the survey. TNTP will keep the identities and responses of everyone who takes the survey confidential.

District-wide rezoning process is underway

To reduce the significant overcrowding and under-enrollment of many local schools, Alachua County Public Schools has begun the process of district-wide rezoning. By using facilities and operating funds as efficiently as possible, the district will be able to focus more of its resources on teaching and learning.

The rezoning process is expected to be completed in November of 2023, with new attendance zones to take effect for the 2024-25 school year.

Community input sessions are already underway, with two scheduled for the month of May. Citizens may also submit their input to rezoning@gm.sbac.edu.



Extended Day open enrollment for 2023-24 is May 1-5

Open enrollment for the district's after-school Extended Day Enrichment Program (EDEP) will begin on Monday, May 1 and close Friday, May 5.

Incoming kindergarten through 5th grade students are eligible for EDEP. Registration priority is NOT first come, first served.

First walls go up for revitalized Westwood Middle School campus



The first walls on what will be a revitalized Westwood Middle School campus went up this week.

The raising of the first wall came after a brief ceremony that included remarks from principal Daniel Burney, Superintendent Shane Andrew and School Board chair Tina Certain. Both Andrew and Certain are Westwood alumni and shared their memories of less-than-ideal facilities when they attended the school. Also speaking were architect Chad Jones of Harvard Jolly and Domenic Scorpio, president of Scorpio Construction, which is building and renovating the campus.

Fourteen buildings have been demolished to make way for new construction. The project is to be completed in the fall of 2024.

The revitalization is being funded by revenues from the Half-Cent for Schools initiative, which was approved by voters in 2018. The Half-Cent has also funded revitalization projects at Howard Bishop Middle, Idylwild and Metcalfe elementaries, a new classroom building at Oak View Middle and a new campus for Terwilliger Elementary School, among other projects.


Deadline to apply for college savings program is April 30
